Subject: Observation of "SEVA PAKHWADA" from 17th September to 2nd October, 2025- Calendar of Activities by ITIs and Polytechnics across the Union Territory of J&K.

CIRCULAR

In pursuance of the directions of the Government of India regarding the observance of **SEVA PAKHWADA** from 17th September to 2nd October 2025, it has been decided that all Government Polytechnics and Industrial Training Institutes (ITIs) across the Union Territory of Jammu & Kashmir shall undertake the following activities as per the prescribed Calendar of Events annexed herewith.

Special focus shall be laid on:

i. Ensure strict implementation of the enclosed activity plan in ITIs/Polytechnic with more focus toward Women and family upliftment.

ii. Co-ordinate with District administration and concerned officers wherever

required.

iii. The activities be undertaken within the Skill Development institutions viz. ITIs/Polytechnics and outside offices such as Block offices, Panchayat Bhavans, District offices, Higher Secondary Schools and Colleges and their extensive social media coverage.

iv. Measurable outcomes such as registration on portals, present and after the programme, persons trained present and after, students/persons sensitised

about various entrepreneur and skill schemes.

v. Submit daily progress report and documentation of activities through photographs, short videos, press releases and social media outreach under the activity planned. A form will be floated for this purpose to upload activity wise photos/videos and necessary document.

Core IEC Activities to be undertaken:

i. Awareness Campaigns: Organizing mass outreach through brochures, posters, hoardings, advertisements, and social media to inform the public about available entrepreneurship scheme-Mission YUVA and scheme related to skill development programs and their benefits viz long term courses offered, Skill India Courses, India Skill Competition etc.

ii. Workshops and Seminars: Conducting orientation sessions, workshops for trainees, industry partners, and stakeholders on the importance of skill

development and employability skills.

iii. Training Programs: Offering training in communication skills, life skills, and

vocational trades to different target groups.

iv. Community Engagement: Mobilizing communities through interactive meetings, exhibitions, and success-story sharing to motivate participation and retention.





v. **Digital and Social Media:** Disseminating information via social media, SMS alerts, and department websites to increase accessibility.

vi. **Capacity Building:** Training personnel (Instructors, Coordinators) in IEC methodology to ensure consistent messaging and effective program delivery.

vii. **Cultural and Targeted Programs:** Customizing IEC material and sessions for specific communities, vulnerable groups, or youth clubs to address unique barriers and promote equal access.

viii. **Monitoring & Evaluation:** Regularly assessing the effectiveness of IEC activities through feedback, participation rates, and impact analysis to refine

strategies.

Joint Director ITIs, Principals/Superintendents of ITIs and Polytechnics shall:

1. Ensure strict adherence to the date-wise schedule of activities.

2. For each activity, Nodal Officer has been identified and specific target have been defined. It shall be personal responsibility of the Nodal Officer to ensure end to end execution of the assigned activity and achievement of the target mentioned in the plan.

3. Submit a daily activity report with photographic evidence to the Directorate. A

form will be floated for this purpose.

4. Furnish a comprehensive final report of activities undertaken by 5th October 2025.

Measurable Outcomes Framework

 - Target during Seva Pakhwada:
 - New registrations of youth/job seekers.
 - Enrolment of industries/employers for apprenticeship.

Outcome Measurement:

- % increase in registrations compared to baseline.
- No. of industries onboarded for apprenticeship.

Training & Upskilling 2.

Baseline (Before 17.09.2025): Number of candidates already enrolled/under training in ITIs/Polytechnics/short-term skill centres.

Target during Seva Pakhwada:

- Additional candidates enrolled in short-term skilling drives.
- Fast-track completion of certain skill courses.

Outcome Measurement:

- No. of new enrolments in short-term courses.
- No. of candidates successfully completing/assessed/certified.

3. Awareness & Sensitisation Programmes

- **Activities:** Seminars, counselling sessions, exhibitions, job fairs, career quidance in schools/colleges, ITI/Polytechnic open days.
- **Baseline:** Average participation in such outreach events before the campaign.

Target during Seva Pakhwada:

- Students sensitised about skill-based career pathways.
- Community members informed about government skill schemes (PMKVY, NAPS, Jan ShikshanSansthan, NSQF integration, etc.).

Outcome Measurement:

- No. of students/community members sensitized (attendance registers, feedback forms).
- % increase in awareness (through pre/post event quicksurveys).

4. Placement & Apprenticeship Linkages

- Baseline: Existing placement/apprenticeship figures in ITIs/Polytechnics.
- Target during Seva Pakhwada:
 - No. of placement camps/job fairs organised.
 - Apprenticeship offers generated.

Outcome Measurement:

- No. of offers rolled out/accepted.
- No. of new MoUs signed with industries.

5. Community Outreach / Social Impact

• **Activities:** Skill Melas, interaction with Self Help Groups (SHGs), entrepreneurship awareness, showcasing success stories.

Outcome Measurement:

- No. of SHGs/entrepreneurs connected to skill programmes.
- No. of self-employment registrations facilitated (PMEGP/Startup Schemes).
